CITIZEN COMMENTS

MR. COGGINS: Nic Coggins, I'm here representing the Trumbull County Planning Commission working with the City of Girard on the Leatherworks project.

So I wanted to talk about Ordinance 51-50, 51-54 and 51-55. These were all change orders for the Leatherworks project. The first one being an addition of \$3,515.00 due to -- they have to hand dig around the existing gas well on the site, so it's going to cost additional labor, instead of just coming in here with an excavator and ripping it out. So that is going to increase the labor costs according to the contract.

51-54 will increase \$5,580.00. This was a REM area calculation in the scope of work. REM is a remediation area, one of the areas that they need to dig the dirt out. We had left the zero off. It was a typo. So to increase based on the tonnage that was agreed to for cleaning the remediated areas out, that needs to be

adjusted for that \$5,580.00.

And then the last one is a little bit -- because the clean fill that has to come onto the site, you have to have -- based on EPA regulations -- a certain amount of clean fill from a certified site. The certified site that they had identified originally cannot be used because there is a project going on. They were going to use it when they broke ground to start building. Well, that project to build has been delayed several months, so they had to find a new certified clean-fill site. Where this new one is located at, it is cost prohibitive to drive from that site to a weigh station, get a tonnage ticket and bring it to the site.

So in order to accommodate the new clean-fill site, we are going to change it from a tonnage for those weight tickets to a lump sum amount so that they don't have to go to the scales and it will be based on volumetric fill, the minimum required -- at least the minimum required by the US EPA to clean these remediation areas with clean fill. And turn it into a lump sum. So it's going up an additional \$750.00 here. Again, that's for that remediation area. Once they take dirty dirt out they have to put clean dirt in. And again, we left the zero off. So that's going to go up \$750.00 for a lump sum fee for that one. So those were the three.

And if you drive by that site right now, they are done with the north side. They drained a clarifier, completely crushed it, filled three lagoons, and graded that area. And they are ready to move on to the south side of the creek on the Leatherworks. If you drive down North State Street I personally think that it looks a million times better than it did before on the north side of that creek.

MR. PAOLONE: Thanks for coming, Nic.

MAYOR MELFI: I think it's important to know that we have been waiting a long time. Obviously not just specifically with the litigation with the Leatherworks. The City of Girard, in a very short time, is going to have 27 acres that the city controls -- the city council controls for development. And we've never had that before. We've never had a light industrial site with that kind of acreage to attract business, recreation. think it's just going to be the start of good things to
