STREETS SIDEWALKS & EMPLOYEE WELFARE-STANDOHAR-KAY-GRUMLEY

Councilman Standohar said they had a street committee meeting this evening at 6 in the service director's office. The administration did present them with 13 streets that they felt in their opinion were in need of immediate attention in this paving program. The committee did accept and acknowledge those 13 streets. The committee did also discuss some other streets and 3 have been added for a total of 16 streets that will be asked for to be placed out for bid at the next meeting on Monday, March 27th and everybody will wait for those in their packet. They will have time to review them and discuss them. Standohar said they tried the best they could to stick with most of the recommendations and at the same time realized there were some possible areas that needed some attention spread out throughout the city to be equitable to all of the wards of the city. Councilman Standohar asked if there was anything his committee members wanted to add. Councilman Kay asked if Jerry needed them, Jerry said he didn't mark everybody's handouts which ones they wanted to add. Kay asked he did? Lambert said he only marked his copy so the three that they wanted to add they didn't have that. Councilman Grumley said after the meeting they would cover the rest. Councilman Standohar said at this stage they are only putting out for bid so they will see how things resolve.

Martuccio said she wants to check with their law director to look into our downtown properties as blighted, as sources of blight for nuisances and/or eminent domain to perhaps do something with our.......Attorney Kren said he does not run the zoning department. Martuccio said she knows but from a law perspective to look at properties as far as eminent domain. She asked if this was something they could look into. Attorney Kren said they would have to have a use plan first. For eminent domain you have to have a public purpose. Martuccio asked you have to have a what? Kren said some public purpose in mind. The federal government....their state supreme court is somewhat restricted with eminent domain. Martuccio asked if it was something they could look at down the road to come up with a plan to look at these properties that are not being utilized. Kren said any property is subject to eminent domain. It is coming up with a plan of action that the eminent domain is based on. Martuccio asked Kren to help guide her, have a conversation and move forward if they can. Attorney Kren said sure. Martuccio said that is all she had.
