MAYOR JAMES J. MELFI PRESENT

MAYOR MELFI:

Mr. Chairman, just a couple of comments: Seems to be a broken record. Zoning, once again our zoning department is out in full force. It's a very busy time of year. High grass. We sent the police down on Market Street about an hour ago. Somebody just thinks that they can clean out a house and put it all over the front yard and the devil strip. I don't know where these folks come from or where they were before, but it is getting a little bit disgusting. But we will stay on it, you better believe. Twenty-four hours a day, any time we see something, we are on it. Even if we're sending the police now. Not to let you think that once they make the first cut of grass that we go away. We do not.

Secondly and finally, I've asked a month ago at the last finance meeting from the city treasurer for certain statistics from 2017 to the present. I also asked for a breakdown of income tax dollars from the business sector from withholding, which would relate to business and others who pay on their own. The treasurer did not provide that. Maybe we have to send a letter to the editor. Maybe the newspaper editor can call and ask him for these statistics. But once again, we do not have them. We have nothing to go on through the pandemic. He is not here to answer questions to this very generic RITA report. So we'll continue to ask and maybe I will write a letter to the editor and maybe she can get the answers. That's all I have, Mr. Chairman.

Thank you, Mr. Chairman. We had some discussion during the finance meeting regarding the 2022 street paving project. And it seemed to be the consensus of council that they were in favor of proceeding only with Contract A that was presented tonight among the options. In fact the finance chair asked if we would present it that way this evening. So that will be presented as Contract A for a price not to exceed \$328,762.08.

I don't think he's closing the door on any other activity that possibly could be done that has been proposed tonight, but I think council wants some more information before moving forward on any of the other paving listed in Contract B. Thank you.

MR. GRUMLEY: Jerry, have we ever used Lindy before?

MR. LAMBERT: It's been a while.

MR. GRUMLEY: I always worry when somebody can come in 75 to 100,000 cheaper than anybody else.

MR. LAMBERT: From what I understand, there was some competitive bidding as well in regards to the paving in Youngstown. And I think that everybody was watching what everybody else was charging and they were trying to manipulate the numbers so that they can be lower on this and that. And it just so happened that Lindy wanted Girard, I guess.

MAYOR MELFI: We have. I have them here somewhere. We are going with a 31-month term from May of '23 to December of '25. And it is 0.06880. And that is the best price available at this time. So we do have the

Now, I've stated this before, the gas aggregation has proven to be magnificent. It's 3.06 per Mcf. And we've locked in as long as we could at that time. But that comes due in October. But I'll tell you what I tell my wife, put on a sweater or two.

MS. MARTUCCIO: Can we say who our aggregate is?
MAYOR MELFI: I can't tell you where we're at with gas.
It's way too soon.

MS. MARTUCCIO: No, with the electric.

MAYOR MELFI: D-Y-N-E-G-Y, Dynegy. And there is a Greenback Program. They are going to -- for all of this they are going to give the city \$11,500.00 for energy consumption or conservancy. But a little bit comes back to the city for energy efficiency programs.

MS. MARTUCCIO: And so our friends with pools for the rest of summer, they can choose someone until next year?

MAYOR MELFI: Absolutely. If anybody is in the city's aggregation — gas or electric — you can always opt out at no cost, no penalty. That's very important to know. When people call me and they ask about these aggregations, I say listen, you want to make sure your opt out is zero. A lot of them get zonked, because they are as high as \$250.00 to opt out. And whatever you are going to save, you're not going to save. The city is zero cost opting out. And we always say that there could

be a better deal out there. There could be a better deal.

MS. MARTUCCIO: That sounds like a great deal but we just

have to wait until next year, right?
MR. PAOLONE: What covers us until May?

MAYOR MELFI: First Energy.

MR. PAOLONE: This is the old contract.

MAYOR MELFI: Yeah. If prices were that cheap.

MR. PAOLONE: So we're just going under First Energy

until May?

MAYOR MELFI: Correct. Of 2023.

MR. PAOLONE: Anybody that is in stays in?

MAYOR MELFI: Correct. You don't have to do anything. MR. PAOLONE: So for a year we are with Ohio Edison and
