CITIZENS' COMMENTS

Fran Wilson, 117 Ella Street. Ms. Wilson stated that she was trying to find the minutes of November of '21 but she didn't have time to research them, but, anyway, when she read the article in the paper about the streets that have been done, the only remark she has to make here is that she had thought that her street, according to those minutes, might have been one of the first streets done. Wilson continued, she is taking count of all of the other streets that are already paved and she asked tonight if they had a date when her street was going to be paved and she was told that they are still going to be talking about it. Ms. Wilson said that she wanted to go on record and say that she would probably pull those up and look at those because the city put in the new waterline and tore the street up and she had to live with that since October or November of last year. Every time she walks out there she has to be careful beause she walks the dogs up one side and tries to stay on the sidewalk but there are times that she does that, and you know how big those rocks are when the street is torn up. Ms. Wilson continued, she had a personal problem recently in her life and a lot of out-of-towners came in town and it was embarrassing for her to have to explain why her street looks so bad for these people from out of state and all of the other ones look so good. She was crying enough without having to say she's sorry they have to drive down this street to come and see her like that. She thanked council.

REPORT OF OFFICERS AND DIRECTORS OF THE CITY

MAYOR JAMES J. MELFI PRESENT

Mayor Melfi said he had just one item. He was informed today by Gary Modarelli, who is the low bidder for the demolition of 15/15 ½ and of course 25, that he will be bringing his equipment in this week and could begin as early as Friday for the demolition of 15/15 ½. The Mayor continued, as they may know, 25 has been challenged by the owner and the thinking is that they are going to repair theirs once ours is down. They will be able to get in it and repair their wall among everything else in the building. They did put two new glass block windows in the back so the cats no longer have entry.

COMMENTS:

Councilman Moliterno asked who owns the building that they are going to tear down. Mayor Melfi responded that it is actually in foreclose and FNB has it. They have been informed.

DIRECTOR OF PUBLIC SERVICES JERRY LAMBERT PRESENT

Mr. Lambert said he had a couple of things. Last year's paving is finishing up as we speak. They only have a few more things to do as far as the manholes and stuff like that. Mr. Lambert continued, the paving that has been done so far is actually last year's list. This year's that they awarded within the last month or so, they are having the pre-construction meeting on Wednesday and hopefully they will be starting as early as next week on this year's paving list. Lambert said he did not have much time to talk too much to Sam before the meeting but he would like to see if they can bring in legislation to advertise for bids for the six pumps at the Tibbets Wick station and the Churchill station. Three at each one. Just to advertise for bids. Lambert said he wants to keep the labor to install it as a seperate entity because it is probably going to have to be a different organization that has to be doing the installation. So, two pieces of legislation, one to advertise for bids for the pumps and one to install the pumps.

COMMENTS:

LAW DIRECTOR BRIAN KREN PRESENT

Attorney Kren stated since the last meeting he did file a claim in Bankruptcy Court against Volunteer Energy based on Buckeye Energy's calculation of their lost savings on the electric aggregation and we'll see where that goes. All of the pleadings have been filed in the traffic camera appeal so they are just in limbo waiting for a decision on that.

COMMENTS:

Councilwoman Martuccio said that they had a zoning committee meeting prior to this and a couple of issues came up that they would ask for his opinion on. One of the main ones is signage in the City on residential properties. People putting homemade signs that most people feel are offensive. Are there any state laws or other parameters that they could abide by. Martuccio asked if he could look into it and let them know. Attorney Kren said if you're talking about political....Councilwoman Martuccio said no this is like feuding. It is like social media at its worst on a sign. It was neighbors directing comments at each other. Attorney Kren said he would be glad to look into it. They took a case to trial where, well he doesn't want to get into specifics, but it was what they believed to be racial harassment. The First Amendment is a high hurdle but they are not shy upon filing charges if appropriate. Martuccio stated that some of the wording could almost entice a neighbor into violence she thinks so she would want to look at that aspect of it too. She said she could meet with him and see the ordinances that they have standing and see if they can improve on them. Mattuccio said this brings her to her next question. Where are, how, they're zoning ordinances are in difference places and spots and she is not sure how to look up an ordinance, a zoning ordinance to be honest to answer people's questions. Help. Attorney Kren said nor does he sometimes because, don't ask him why that since 1970 the City has never codified its zoning codes and it just compounded worse and worse as they amend. That is the next step, to codify. Everything except the original zoning code is online. The zoning code they do need to get. They will be an upfront expense. There was further discussion between council and the law director regarding how to get these ordinances included in the codified books and online. Councilman Moliterno asked Attorney Kren if there is something they can do as council to fix the problem please let the know at the next meeting.
