## REPORTS OF OFFICERS AND DIRECTORS OF THE CITY

MAYOR JAMES J. MELFI PRESENT

Mayor Melfi stated he had a couple of items this evening. He continued, as you see before you the Resolution to demo the two structures downtown. Some preliminary numbers were coming in and certainly they were exceeding the limit that the administration is allowed to contract so they want to bring it in front of council. As he said all along, they are making council step by step in this process aware of what is going on and we will go from there. The Mayor stated also on a couple of properties that they have been working on for sometime on Washington Avenue, 909 Washington Ave. is slated for demolition and there doesn't seem to be any problem there. Unfortunately, 1047, which has been a big nuisance, and if you happen to view the interior pictures of 1047, they were quite nauseating. Apparently there has been a transaction between the current owner and the new owner. The Mayor stated that he spoke with the County Treasurer and he is going to continue forward with the foreclosure action. There are quite a lot of liens on the property. There has been a shallow attempt at cleaning the property up. Melfi said they put a new roof on and left piles of shingles on the ground, without taking out a permit of course, so they have not been inside, but obviously they are going to delay that until they get a little more information. 909 is scheduled and could go at any time. Also, there is a tentative agreement with the railroad. The Mayor stated that after sixteen years there is a tentative agreement. Melfi said the Law Director wanted him to inform Council this evening and the President of Council that they have an email providing all of the details. The Mayor further stated that he is not going to call for an executive session tonight out of respect that he just sent it out. This way it gives council an opportunity to review and ask the Law Director when he is

there. It has been a long, long task. The Mayor said he has read the details and they look pretty good. It remains with the Law Director and executive session of Counci he would imagine at the next meeting.

President of Council Paolone stated that the Law Director informed him on the phone today that anyone on Council that wants to call him please do so and discuss the email. At the next meeting he will have some legislation for them to move forward because it will require legislation to do this. He said any questions just call him just like the Mayor said.

The Mayor said his only other comment is there again he has not had any information on income tax. The Mayor asked Councilman Moliterno if he had anything on income tax numbers for them. Melfi said he would like to know where they stand. Councilman Moliterno said that he is not sure why he would have any more.

## **COMMENTS:**

Councilman Kay asked 15, 15 ½ and 25 which two buildings are those? Is that the building and the building behind it or is that just two addresses? They Mayor stated that is two addresses at the same building. The former Sackus building, Z Fitness. The Mayor said he doesn't understand why but it is there and they are going to include it. They are not going to leave anything out. Kay asked the other property behind it is? The Mayor said that is part of the Sackus property but remember we are condemning, it's a different process, they are condemning 15 based upon 15 ½ condition that it may fail and it is dangerous to the public. The Wilson Avenue property doesn't fall into that category as of yet. Although, if you may recall, a year or so ago a major wall fell down, the east wall fell on that building. But, no, their target is the Ben Franklin Building. The Mayor said unfortunately, they are delayed because of the dangerous conditions of the adjoining wall. Kay asked who owns that property behind there? If they knock it down then the City owns that property right? The Mayor responded that no. First of all, he is going to leave all questions to the Law Director, but he believes that they will lien the property for the cost incurred by the City and they will go from there. Melfi said, obviously he has already been in contact with the County Treasurer, he understands what they are going to do and they have to recoup their money. If they don't recoup their money then, obviously, it is going to be City property and then City Council will determine what they would want to do with that property. Councilman Grumley said that brings him to his question. Grumley asked if he could get them an answer if they could use the available Covid funds for the demo and also to replace it with a park type setting. The Mayor responded that unfortunately they are delayed because they have to advertise now so he is sure he can get that answer for him.

# SAFETY/SERVICE DIRECTOR PRESENT

## **JERRY LAMBERT**

The Service Director said he had a couple of things. He continued, like the Mayor said about the demolition if they can get that passed tonight it is just to advertise of bids. The second thing on his list is the piece of legislation for the streets. Lambert stated that the original legislation that was passed they interpreted it somewhat as him being able to advertise for bids without doing anything further paperwork, but just for precautionary sake he thought they would bring it up this way just to say okay advertise for bids for the street paving. If they can pass this thing tonight, the money will not be available until July 1<sup>st</sup> anyway, if they pass this tonight again they will advertise on June 21<sup>st</sup> and open the bids on July 15<sup>th</sup>. Jerry said that is the timeline right this minute. If they don't, it will be a couple more weeks. Lambert said they are also getting prices

on painting the lines on Liberty Street, 422 and Shannon Road, wherever they need it. As soon as they enter into a contract with the people they used before they will also be doing parking spaces for the handicap on Liberty, especially on the one side of the street and maybe some, on the south side they will put down four of them and then one or two on the north side. He said they are also going to line a couple of handicap spots down on Market Street. Line it all so that the bars will have spaces just in case they need them. They are getting prices on that and hopefully they will have a contract before the next council meeting. Lambert said that he did not have a chance to talk to the safety committee. He apologized to Coucnilman Grumley but said that some of these things just went across his desk today. John wants them to bring in legislation to request a mutual aid agreement with Mahoning, Trumbull and Columbiana counties for law enforcement if they could bring that legislation, just a Resolution to pass this for the mutual aid part. They also would like to, again Tom they just talked about this today, put on the agenda the original and amended ordinance because the Law Director is not here to say which one they should use, just to address the part time dispatchers for possible amendment. Lambert said they will talk to him about it before this thing comes up. He said if they could bring those two pieces of legislation, well the second to put it on the agenda for the next time. Jerry said the Fire Chief and he spoke in the morning and they are trying to put into motion to condemn the old Racik Dairy building across from the old high school. They are starting that process today.

#### **COMMENTS:**

Councilman Grumley asked if they could bring in the new hires from both the police and fire department so they could be introduced to council like they were doing before. Jerry responded yes. They have one in the fire department and two in police, LaPierre and Maura.

She stated that would go under economic development and maybe building and grounds for a caucus at 6:15 pm on the 28<sup>th</sup>. President of Council asked Councilman Schubert if that was okay with him and he said it was.

Zirafi said he would like to throw out just for consideration maybe they should get a company in to take a look again at the cemetery, parks and lakes, especially the upper lake. If we are going to sell it if there is something they can harvest to bring in money why not do that. Just throwing it out for food for thought.
