Ladies and gentlemen of council, I want to introduce you to Sean Guy. Sean is our newest firefighter/medic. He was appointed by the Mayor in May to his full-time position. Sean is a graduate of Poland Seminary High School. While he was still in high school he joined the Poland Township volunteer fire department as a cadet in 2013. He is still an active lieutenant with that fire department.

In 2015, after he graduated from high school, he attended Mahoning County Career & Technical Center for Fire Academy where he received his Firefighter 1 and 2 certifications. Also in 2015 he received his EMT basic certification at YSU.

From 2015 to 2020 he worked for various ambulance companies, including Clemente and AMR, and also worked as a part-time firefighter in McDonald, Brookfield and here in Girard. He was part of our part-time program.

He received his paramedic certification through the University Hospitals in December of 2020.

I want to thank the Mayor, because this was a really time-crunched appointment. Thank you for acting on it so quickly. We had an unexpected resignation and we had to get this done to keep our staffing levels as they are.

All I can say is that I know we got a good one here and I look forward to having him and having him serve the people in Girard for a long career as a firefighter/medic in our city. Thank you.

And the one that you added tonight is also for dispatchers. We are having a very difficult time getting dispatchers and we want to make that figure exactly the same. Those are the two.
