## REPORT OF OFFICERS AND DIRECTORS OF THE CITY

MAYOR JAMES MELFI ABSENT

#### **JERRY LAMBERT**

**PRESENT** 

Mr. Lambert said he had just a few things. First thing, salt barn. The engineer's estimate was \$330,000 for the work that was supposed to be done in addition to the building itself. There were three bids that came in. They ranged from \$431,000-\$729,000 so the salt barn itself has to be rebid and a couple of the things they were saying as to why the prices or so high was because it was so late in the year and because of the weather. Tommy and he spoke earlier in the week. Tommy Watts is going to do his best to get the thing as good as it's ever been. Lambert said they are worried about the safety but he feels they will be okay with using what is there. A lot of the salt that they have is being stored up in Liberty so they have to get that back from Liberty and then be prepared for the snow season. The second thing they have is Eastgate. They had the meeting down there. The funding projects was 78 points or higher funded. The Tibbets Wick pumpstation received 79 points so they will definitely get funded for the fiscal year starting in July of '24. The total project cost for that one was \$701,000 and the local share is \$322,000 so they will be advertising for bids for that thing probably March or April so they are ready to do it in July. The Mosier Road line that goes under 80, you had to be over 78 points, that thing came in at 77. Probably, the story he has heard in the past was that any project that scored that high in the year before it is usually good for the year after. Lambert said he would think this one would be up for being done in '25, the Mosier Road bridge. Mr. Lambert said the third thing he had is that since they don't have a contract with Republic right now, until the bidding is over they are going to be increasing the charges that they are giving us by 25% in November and December or at least until the bids are in and if they win or lose or whatever. They would like to pass legislation tonight and he could probably put it out for bid as early as tomorrow, not tomorrow but maybe tomorrow, Wednesday or Thursday. If they can get away with just advertising for two weeks maybe before the end of the year, before the last meeting they can get a new contract approved so he will be putting that thing together to advertise for bids. Mr. Lambert said he doesn't think he should need councilmatic action for that since it's only 25% for one month right? Mr. Lambert asked if he could ask Sam that?

Councilman Zirafi responded that he doesn't know but he would presume that he should. He's (Attorney Kren) not here, but you're extending an existing contract with a price increase and that price increase will be in excess of, he doesn't know. He doesn't know what the current rate is, but he doesn't know if he wants to make it more, in other words if you want to make sure that you are covering all of your basis you would ask council to approve. Mr. Lambert asked council to just bring in legislation to just say that on a

monthly basis they would pay the Republic Waste Company a 25% increase each, not on top of each one, 25% would be for November, December whenever the contract is done, if they could bring in legislation like that to cover him since Kren is not there.

Councilwoman Martuccio said she doesn't understand.

Councilman Grumley said he is not going to be comfortable doing anything without the law director. With that being said, how long would they extend our contract with this 25% increase? Lambert said he thinks with the 25% that's what they wanted for the first year when they were talking about extending it anyways and it was 25% the first year, and he thinks, Councilman Schubert said 5% after that. Grumley said so that's basically what their bid is coming in at. Mr. Lambert said it may be higher. Grumley said it may be higher but they can't be at the 11th hour of a contract of this magnitude saying that they are going to cut corners when there may be another company out there that will give them a better deal. President of Council Paolone said that is why they are bidding it. Grumley said he understands that but they can't do a two week. That's not fair to anybody. These guys have been here 23 years... There was back and forth conversation between Grumley and Lambert that Paolone stopped and said let's stay in order, Tom then Jerry. Councilman Grumley said he is totally in agreement to ask for bids, but it can't be a rush deal at this point. If they come in in January or February and they say it's 40% then it's 40%. Their bid is going to be their bid, but everybody has to understand that they have to be bidding apples to apples. Grumley said he has been complaining about the same trash on the curb for three weeks. They have to understand what they are getting with this package. Are they expecting Republic right now to pick up too much trash? Grumley said he does not know that answer, but he drove around Sunday and he seen mattresses, beds, and everything all over the place. All over town. Not just in one neighborhood, it was all over town. He said he has a watchdog that sits next to him and points it all out to him. He said they have to do this right. This is, what was it, \$400,000 the last time or something right? Mr. Lambert said he thinks it was more than that. Grumley said it can't be done in two weeks. Mr. Lambert said all he is saying is that if they want to try to get it done before the end of the year fine. If they want to hold off he just needs something covering him for extending this thing in November, December and January with that 25% because he doesn't want somebody to come back on him and say why did you do it without getting council's approval. Lambert said if they want to do it January he doesn't care. Lambert said he know they are going to bid. It might take them awhile to get the bid specs together because he has a feeling that a lot of the things they are doing now may not be included without another fee. He doesn't know until he sees what, how they are going to put it out, how they are going to bid it.

Councilman Schubert said they had a meeting with them a few weeks ago and they said the 25% going into next year. Why is that now being asked of now and not until the end of the year? Mr. Lambert said because they thought, well it is going to be until the end of the year. It is going to be November, December. Schubert said but they said they wanted it after January 1 not November, December. Lambert said he really didn't say it that way. He thinks the idea, when he was there with them they were under impression because of their conversations with the law director, that they could extend the contract and he would have been fine with that to start the thing all over again with those things once we agreed with that, but now since they basically do not have a contract they are saying they want it now. Schubert said so we don't have a contract currently? Lambert said they haven't had one with them since 1990. Paolone said he's been trying to tell them that. Grumley said don't even go there. President of Council Paolone said that's why he is not saying anything and Mr. Zuppo said but you did.

#### **COMMENTS:**

Councilman Grumley said pertaining to salt barn. On the larger barn, the one that he thinks, by his own vision without being an engineer, the one he thinks is more secure structurally on the sides and so forth, are they going to put a patch on roof so they can use that? Mr. Lambert said he just talked to Tommy about it and he told him what he was going to get done and he didn't see him for a couple of days and he saw him today because he was back to work today and they really didn't go over it. He just said what do you want me to tell council and he said it is not going to be any worse than it's been the last couple of years. That's all he said. He knows he is talking about calling a roofing contractor to try and see if they can do something with the roof and with insuring that the sides would be okay too. Lambert said that is all he has. He's going to make it work. Councilman Grumley said he doesn't know how they are going to make that salt barn work but that's honestly his responsibility. Mr. Lambert asked whose responsibility? His responsibility? Grumley said yea. You're the man in charge right now. It's not him he can't say shut it down. Lambert said no and he can't ..... Grumley and Lambert were talking at the same time and President of Council said they're going there again. Mr. Lambert said it's just like Grumley was saying before, council bid the thing. Now, is it his fault that they didn't put the bids in until the end of the year and they got those prices? Lambert asked if he is going to blame that on him too? Tommy said he is going to make it work. He has made it work for the last ten years with that salt barn being that bad and that is the way they are going to do it. Grumley said that he is going to be asking tonight that they rescind 51-70 so that they are coming out next year with a clean slate. Lambert asked which one? Grumley said 51-70. The one that passed. President of Council asked if he wants it on the agenda for the next meeting? Grumley said no they already passed it. He is going to ask for it to be on the agenda.

Councilman Kay said we haven't purchased anything yet? Mr. Lambert said they purchased the actual unit itself. Kay said they purchased the unit just to put it up but they still spent all that money on the building itself. Lambert said \$85,000 and they just asked the guy if they would hold off delivering it until the spring and he said he would.

Councilman Standohar said this is for Monica, if you could strike Councilman Grumley's comments about a watchdog being in the car with him to a lovely lady with an eye for detail.
